DRAFT PROGRAMMATIC ENVIRONMENTAL IMPACT REPORT

NOTICE IS HEREBY GIVEN that the City of San Mateo Clean Water Program Draft Programmatic Environmental Impact Report (Draft PEIR) has been completed and is available for public and agency review.

PROJECT NAME: City of San Mateo Clean Water Program

PROJECT LOCATION: The Program Area for the Clean Water Program is the area where CWP projects would be constructed and operated, generally within the City of San Mateo. Collection system projects would be located throughout the City of San Mateo, primarily in the eastern half. Wastewater treatment projects would be located at or immediately adjacent to the existing wastewater treatment plant, located at 2050 Detroit Drive near J. Hart Clinton Drive at the eastern edge of the City.

PROGRAM DESCRIPTION: The Clean Water Program is a series of projects to upgrade and increase the capacity of the City's wastewater treatment plant and sewer collection system to eliminate sanitary sewer overflows and meet current and future regulatory requirements. Two alternatives that meet the Clean Water Program objectives are evaluated at an equal level of detail: the In-System Storage Program and the Full Conveyance Program. The In-System Storage Program would include construction of one or more underground storage basins upstream of the Dale Avenue Pump Station to detain wastewater flows during peak wet weather events. The Full Conveyance Program would include a new pump station next to the existing Dale Avenue Pump Station, larger pipelines to deliver peak wet weather flows to the wastewater treatment plant, and storage basins at the wastewater treatment plant to accommodate the increased flow. The New Headworks Project and the Primary Clarifier Project are the first to projects proposed for construction; these projects are evaluated at a project level of detail.

SIGNIFICANT ENVIRONMENTAL EFFECTS: The In-System Storage Program, the Full Conveyance Program, the New Headworks Project, and the Primary Clarifier Project would result in significant and unavoidable construction noise and vibration impacts, even with proposed mitigation to reduce impacts. All other impacts with potential to occur during construction or operation of the In-System Storage Program, the Full Conveyance Program, the

New Headworks Project, and the Primary Clarifier Project would be less than significant or reduced to a less than significant level with proposed mitigation measures. These impacts include aesthetics, air quality and greenhouse gases, biological resources, cultural resources, geology/soils, hazards/hazardous materials, hydrology/water quality, land use, population/housing, public services, recreation, transportation/traffic, and utilities.
